- Proposal filed by Pinnacle Public School, Limbadia, Near Narmada Canal, National Highway No.8, Nana Chiloda Circle, Gandhinagar-382330 for Higher Secondary Standard (Sci & Gen) – CBSE English Medium for the Academic Year 2019-20, along with relevant documents.
- 2. Final order passed by Fee Regulatory Committee (FRC), Ahmedabad Zone for Academic Year 2017-18 for Pre- Primary to Secondary standard (CBSE English Medium).

PROVISIONAL ORDER DATE: 23.09.2019

 Pinnacle Public School, Limbadia, Near Narmada Canal, National Highway No.8, Nana Chiloda Circle, Gandhinagar-382330 for Higher Secondary Standard (Sci & Gen) – CBSE English Medium for the Academic Year 2019-20, along with relevant documents. The Fee Regulatory Committee (FRC) Ahmedabad Zone has considered the said proposal as well as the documents attached therewith. The FRC has also considered the Final order passed by the



FRC on 1-08-2018 for the Academic Year 2017-18 for Pre-Primary to Higher Secondary standard.

- 2. From the Perusal of the proposal it appears that the school was running upto Secondary standard till Academic Year 2018-19. The school has however received the permission for Higher Secondary standard on 13-06-2019. The school has therefore started Higher Secondary standard (Gen-Sci) from the Academic Year 2019-20 and submitted its proposal. It appears that the school has not made any proposal for Pre Primary to Secondary standard for the Academic Year 2019-20 as the school might have satisfied with the 5 % rise given by the FRC every year in the fees determined for earlier year. As per the order passed by the FRC on 1-08-2018 for the Pre Primary to Secondary standard, the FRC has determined the fees of Rs.54,000 per student for Secondary standard for the Academic Year 2017-18. If the fees for Academic Year 2017-18 were determined at Rs. 54,000 per student for Secondary standard, the fees for the Secondary standard for Academic Year 2018-19 would be Rs. 54,000 plus 5 % thereof, meaning thereby the fees for the Academic Year 2018-19 are Rs. 56,700. If 5 % amount is further added in the fees of Rs. 56,700 for Academic Year 2018-19, the fees for Academic Year 2019-20 for Secondary standard would be Rs. 59,535. The FRC therefore determines the Provisional Fees for Higher Secondary standard (Gen) at Rs. 60,000 and for Higher Secondary (Sci) standard at Rs. 65,000 per student.
- 3. The school has submitted the audited accounts of the trust namely Light Foundation for the year ending on 31-03-2019. The school has also separately submitted accounts of the school and as per the said accounts, the school has received fees income of Rs. 1,88,45,511, transportation fees of Rs. 52,53,313 and late fine fee of Rs. 1650. Thus the total fees income received by the school was Rs. 24100474 out of this fees income, the school has given discount on fee at Rs. 593073, fee refund of Rs. 31744 and scholarship to students of Rs. 205800. Thus after deducting total amount of Rs. 830617, the net fees received by the school were Rs. 23269857. As far as total expenses are concerned, the school has claimed rates, taxes and cesses of Rs. 7315368 and transportation expenses of Rs. 4332912. After deducting all expenses incurred by the school, the school has shown surplus of Rs. 144389. The

school has received surplus of more than Rs. 9,00,000 from the transportation. Even if transportation is considered as optional services, such optional services are not meant for any profit. Even the school building rent shown by the school at Rs. 72, 00,000 is also on the higher side.

4. Considering the above facts and circumstances of the case, the provisional fees determined by the FRC for Higher Secondary standard (Gen-Sci) for Academic Year 2019-20 are as under.

Terms and Conditions:

- 1. It is directed that the School is not permitted to collect fees for any quarter of 2019-20, more than provisional fees determined for the year 2019-20.
- 2. It is also made clear that school is not permitted to collect more fees for remaining quarter of 2019-20 than the provisional fees determined by the Committee.
- 3. It is further made clear that the school is not permitted to collect fees under any other head including under the head of Admission Fees except one month fees by way of admission fees only in case of new admission and thereby causing no extra burden on the students. However, all such fees are to be calculated under one head only.
- 4. Any other fees collected under the head transportation, uniform charges and meal or food charges or for other activities should be optional and the same



should not be made compulsory. The details of such fees should also be furnished to the Committee.

- 5. Any violation of this order shall be dealt with by the Committee in accordance with law, on being brought to the notice of the Committee by any aggrieved party.
- 6. If the school management has any grievance against the provisional fees determined by the committee, it shall have a right before the FRC within one week to raise an objection from the date of receipt of this provisional order.
- 7. The school is directed to place the order determining provisional fees on its notice board as well as on its website.
